ORDER

MICHAEL D. LISSNER, as Guardian of the Property of [REDACTED], an Incapacitated Person, having filed a motion dated July 1, 2013 seeking court-ordered authorization to create and execute a revocable trust for the Incapacitated Person pursuant to Section 81.21(a)(6) of the Mental Hygiene Law and to fund said trust with assets certified as Restitution which were distributed to compensate the Incapacitated Person's family because of their suffering and losses as victims of National Socialist and Nazi persecution, and upon the Affirmation in Support of Motion of Michael D. Lissner dated July 1, 2013, and upon the Guardian's and his firm's significant experience with asset protection and Medicaid planning for Survivors of the Holocaust, and the said motion having come before this Court on July 16, 2013 and no opposition having been heard; and due deliberation having been taken;

NOW, on motion of LISSNER & LISSNER, LLP, attorneys for the Guardian of the Property, it is hereby

ORDERED, that the Guardian of the Property is authorized to establish and execute a revocable trust for the benefit of [REDACTED] an Incapacitated Person, pursuant to Section 81.21(a)(6) of the Mental Hygiene Law, in the form submitted to this Court with the motion herein, with MICHAEL D. LISSNER as initial Trustee; and it is further

ORDERED, that the Guardian of the Property is authorized to, and shall, fund the revocable trust for the benefit of [REDACTED] an Incapacitated Person, by transferring all of the Incapacitated Person's assets, and any and all additional future funds, income and resources, whenever acquired and from whatever source that that can be certified as Restitution which were distributed to compensate the Incapacitated Person's family because of their suffering and losses

as victims of National Socialist and Nazi persecution; and it is further

176 ORDERED, that the Guardian of the ^{*Property*} Person shall take appropriate steps to convert the Guardianship bond to a ^{*Guardian/Trustee*} Trustee's bond, and that the Surety shall comply with such conversion, *and said* bond shall be *filed for approval with the Court.*
